Course Description: This course is intended to help students develop an "economic intuition" or a systematic way of thinking necessary for examining individual as well as societal decision making process and their outcomes. Economics is a social science that addresses these decision making processes by analyzing how individuals, groups, as well as the society as a whole, allocate scarce resources among competing uses. Microeconomics studies individual and group decisions, i.e. that of households, firms, labor unions, etc. and their simultaneous outcomes in the course of market interactions. Macroeconomics addresses the economy as a whole. After completing this course, students will be able to critically assess the economic issues, the potential and the limitations of economic policy.

Textbook: <u>Principles of Economics</u>, 6^{th} Edition by N. Gregory Mankiw. While this is the recommended edition, feel free to use the 5^{th} edition of the book as the differences between the two editions are not significant.

Attendance: Attendance to class is required and is strongly recommended. This course covers a large amount of material in a relatively short period of time. Hence, in addition to the direct loss of grade points, absenteeism is likely to have a negative impact on your understanding of the material. You will be responsible for missed material and announcements. Office hours cannot be used as a substitute for missed classes.

Grading: Grades will be based on attendance, class participation, homework assignments, a midterm exam and a comprehensive final exam. The weights carried by these components are as follows:

The final letter grade will be assigned on the basis of a 100 point scale. Students are responsible for all assigned readings and all the materials covered in class.

Homeworks: There will be four homework assignments, with the due dates as specified in the class schedule. You will be notified in advance in case the dates are changed. Homework is due within the first ten minutes of class. Homework turned in later but on the due date will receive half credit. No credit will be given for homework turned in after the due date. There will be no makeup or extra credit assignments. You are allowed to work in groups but everyone must turn in his or her own version of the homework.

Exams: There will be a midterm on May 31 and a final exam on June 18. There will be no makeup for a missed midterm and the weight of the missed exam will be transferred to the final exam. In case of a missed final exam, you will have to obtain official permission from the Dean's office for a makeup exam. The format for each exam will be specified in class prior to the exam. All the material covered in class and in the relevant textbook chapters is fair game. You should bring writing equipment (pens, pencils, erasers), a basic calculator, a Scantron sheet and your UNC id card to the exams.
