

## SYLLABUS

Course: ECON 411. Game Theory. 3 Credits.

### Course Description:

This is an introductory course to non-cooperative game theory. We will study strategic behavior in different environments (static vs dynamic, under certainty vs under uncertainty). The emphasis will fall on economic applications: oligopoly behavior; bargaining; etc...

Target audience: This course is aimed at anyone who completed ECON 410.

Requisites: Prerequisite, ECON 410 with a grade of C or better.

The course main goal is to provide tools to enable you to: 1) build models of strategic behavior, 2) identify their (built-in) limitations and 3) think about how to apply them to real-life problems;

No prior knowledge of Mathematica is required for one to succeed in this course.
